### Please ensure that you put your parent name and child/children's names (if possible) as a reference for payment.

- We will advise you of performances as far in advance as possible. Dancers are expected to perform at a reasonable number of functions per year. No shows are not acceptable. You/your children must attend the proba immediately before any performance. If you are not able to attend you will not be able to perform. The choreographer/dance teacher has the final say on which dancers will perform at any event.
- Children in Avala 1 & Avala 2 are provided with a nosnja, where possible. Once in the Sumadija group and above all dancers are required to own their own Sumadijska nosnja and to borrow Sv Sava owned nosnje. Parents/dancers are responsible for the return of all borrowed nosnje (washed and ironed as advised) by the next proba after each performance. If nosnje (or any part of the nosnja) is not returned or damaged, you are liable for the full cost of replacement.
- During rehearsals and lessons, all dancers must be respectful of our teachers and talking and the use of mobile phones are not allowed.
- Parents are responsible for the care and behaviour of their children whilst on Church property and everyone is bound by the Constitution of the Serbian Orthodox Church of Australia and New Zealand and The Rules of our Parish. Bad behaviour will not be tolerated. Please also ensure that you clean up after your children. If your child is involved in bad behaviour he/she will be asked to leave and parents will be responsible for any related damages or costs.
- The riding of scooters, skateboards, bikes, playing with balls or generally playing or running through any part of the church hall is not allowed.
- Please ensure that noise levels are minimal during proba as it is difficult to teach dancing or school when other children and parents are making excessive noise.
- Parents or dancers are required to assist in fundraising activities such as Friday night kitchen duty, zabava and festival/stall duties to help with the costs involved in dancing and Serbian school. Fees for dancing, Serbian school and other activities organised by the School & Folklore Committee are subsidised by fundraising activities. As you are a part of this community, it is important that all parents and families offer and help whenever requested.
- Ensure that you advise the President or School & Folklore Committee of any medical conditions related to you or your child/children that we should be aware of.
- By enrolling or having your children participate in folklore, skola or bible studies you expressly agree to be responsible for your/your children's behaviour and agree to personally accept the conditions set out above including the provision of a release and indemnity as per above.
- It is a requirement to fill in a form each and every year you participate in school and folklore.

We ask for your cooperation in collecting the fees as soon as possible to ensure that activities can be organised and to pay our teachers in a timely manner. Announcements and updates will be sent via email. Please ensure that you update your contact details/email address on your enrolment form <u>each year</u> and regularly as it is important that we can get in contact with you to send regular news and updates.
